

Father Stevens Named Rector of Theological College



The Provincial Council of the Society of St. Sulpice, Province of the United States, has appointed Sulpician Father Gladstone H. "Bud" Stevens, P.S..

S.T.L., Ph.D. as Rector of Theological College, the National Seminary of The Catholic University of America in Washington, D.C., effective July 1, 2023. This appointment has received the requisite approvals of Cardinal Wilton D. Gregory, Archbishop of Washington, Peter Kilpatrick, Ph.D., President of The Catholic University of America, and The Very Rev. Shayne Craig, P.S.S., Superior General. Father Stevens, a priest of the Archdiocese of Louisville, Kentucky, was ordained in 2000, and

joined the Sulpicians in 2002. He is a member of the Provincial Council of the Society of St. Sulpice, Province of the United States and is the First Consultor. A native of Connecticut, he was raised in Nashville. He graduated from Quincy College in Illinois in 1989, and earned a doctorate in theology from Marquette University, Milwaukee in 1997. His specialization is systematic theology, and he regularly teaches courses on the Priesthood, and the Eucharist. Fr. Stevens has served on the formation and academic faculties of St. Mary's Seminary and University in Baltimore, Maryland and as its academic dean, praeses, and vice rector. He also served on the formation and academic faculties of St. Patrick's Seminary in Menlo Park, California and as academic dean, vice

rector and rector. He was a member of the committee that composed the Sixth Edition of the Program for Priestly Formation for the United States. He is a highly regarded retreat and convocation leader for priests. He also regularly assists in parishes, celebrating liturgies and giving conferences. He is a chaplain for the Order of Malta. Theological College is the National Roman Catholic Seminary, affiliated with The Catholic University of America. Founded in 1917, Theological College is owned and operated by the Sulpician Fathers, who have been dedicated to priestly formation in the United States since 1791.

Faculty News



Fr. Phillip J. Brown, P.S.S. and Fr. Frederik Hansen, P.S.S. (cand.) attended the annual convention of the Canon Law Society of America during the week of October 10. Fr. Brown gave a presentation on the meaning of "vulnerable person" in the seminary setting for purposes of sexual abuse policies and law. The presentation was followed by a panel discussion

on the general topic of the evolution of the concept of "vulnerable persons" in the law. Fr. Brown continues his work with the Society of Our Lady of the Most Holy Trinity, in particular assisting with its efforts to obtain pontifical status. Fr. Brown was appointed to assist the Society by the Vatican in 2012 and has been working with them continuously since then. Fr. Brown also continues as member of the Publications Advisory Board of the Canon Law Society of America, the Board of Trustees of the St. Thomas More Society of Maryland, and the Board of Directors of the Charlestown Senior Living Center, in addition to acting as canonical consultant to a number of ecclesial bodies.



On April 17 and 18, Fr. Dennis J. Billy, C.Ss.R., gave talks to the Spirituality Year at St. Charles Borromeo Seminary in Conshohocken, PA and, at a conference, to the students at Immaculata University in Malvern, PA.



Dr. Dennis Castillo has been asked to join the Membership Committee of the American Catholic Historical Association. He also gave a paper in Philadelphia on January 7 at the American Catholic Historical Association. The paper was titled "A Tale of Two Earthquakes: The Knights of Malta and Disaster Relief in 1783 and 1908."

Dr. Matthew J. Dugandzic had an article accepted in the journal Nova et Vetera, called "Reason, Passion, and Metaphysics in Bonaventure: Against Hylomorphic Enthusiasm." On October 3, he gave a talk at Harvard called "Aquinas on the Existence of God: A Deep Dive into Aquinas's First Way." Dr. Dugandzic has recently engaged in the fol-

lowing activity: submitted the final draft of an essay called "Aquinas and Moral Conversation" that will appear in a volume published by De Gruyter; submitted the final draft of an essay called "Veritatis Splendor and Intrinsically Evil Acts" to a volume that is being submitted to CUA Press; wrote an essay for Our Sunday Visitor on fasting that appeared in one of their Lenten issues; gave a talk at Johns Hopkins Medical School called "The Morality of Artificial Reproductive Technologies." He gave a paper on April 18 called "What Constitutes Grave Matter?" at a conference for moral theology professors held at Mundelein Seminary. On April 26, Dr. Dugandzic gave a talk called "The Case for Free Will" at the Thomistic Institute chapter at the University of Illinois Urbana-Champaign.



On October 4, 2022, **Dr. Michael Gorman** gave the annual Scherer Lecture on missiology in Chicago, co-sponsored by the Catholic Theological Union, McCormick Theological Seminary, and Lutheran School of Theology at Chicago. It was titled "Resurrectional Cruciformity: Paul's Missional Spirituality." On November 1, he addressed faculty at

Theologische Universiteit Kampen | Utrecht in the Netherlands (via Zoom) on the topic of salvation and shalom in his various publications. On November 2, he lectured remotely on Pauline theology at Seminário Teológico Jonathan Edwards in Caruaru, Brazil. On November 19, he discussed his work on Paul in the Missional Hermeneutics Forum at the annual meeting of the Society of Biblical Literature. On December 2, he lectured at Providence College in Rhode Island on the topic "Participating in Christ: Explorations in Paul's Theology and Spirituality." In early 2023, Dr. Gorman published three articles in the new second edition of the Dictionary of Paul and His Letters: "church," "cruciformity," and "in Christ." He also published an essay entitled "The Discipline of Cruciformity: Civil Religion and the Missional Power of the Cross" in the book Singing into Splintered Spaces: The Rhythms of Mission and Spiritual Discipline (Cascade). His newest book, The Self, the Lord, and the Other according to Paul and Epictetus: The Theological Significance of Reflexive Language (Cascade), was released in March. Over the last year, some of his books have been translated into other languages: Apostle of the Crucified Lord and Reading Revelation Responsibly into Portuguese; and Romans: A Theological and Pastoral Commentary into Spanish. With Fr. Paul Maillet and Dr. Rebecca Hancock, he has written an essay called Teaching Scripture in a Catholic Seminary" for The Seminary Journal.



Fr. Fredrik Hansen, P.S.S. (cand.) attended the annual conference of the Consociatio Internationalis Studio Iuris Canonici Promovendo, held at the Institut Catholique de Paris, September 13–16. The topic of the conference was "Person, Law and Justice: The Contribution of Canon Law." His article "Papal Legates and the Jurisdiction of Diocesan

Bishops" was published in *The Jurist—Studies in Church Law and Ministry*, the journal of the CUA School of Canon Law (volume 78/2 [2022]: 477–99). The article examines the relationship between diocesan bishops and papal legates in relation to the power of jurisdiction (*potestas regiminis*), considering both the historical development of this relationship and current legislation based in the Second Vatican Council and the 1983 Code of Canon Law. He has been selected to be part of a group of scholars to further analyze and contextualize the "National Survey of Catholic Priests." The survey was conducted by *The Catholic Project* at the Catholic University of America, and the initial report on its findings was released in late 2022.



Ms. Emily Hicks facilitated a joint faculty and seminarian intercultural workshop on Resolving Conflict in Intercultural Interactions. On April 28, she defended her S.T.L. thesis entitled Natural Law, Friendship, and Culture as Interpretive Lenses for Meaningful Intercultural Dialogue. She has been promoted to full-time faculty status as Assistant Professor

of English and Culture and is Director of Language Resources and Intercultural Integration.



Dr. Brent Laytham chaired a reaccreditation team visit to Bexley Seabury Seminary for the Association of Theological Schools in October. In January he attended the annual meeting of the Society of Christian Ethics, cochairing the Liturgy and Ethics interest group. This spring Dr. Laytham served on the nominating committee of the Society of Christian

Ethics, attended the Silber-Obrecht lectures on Interreligious studies and sessions of the Sacra Doctrina conference held at St. Mary's in June.



Fr. Robert F. Leavitt, P.S.S., (St. Mary's 1968) delivered a eulogy in memoriam about Fr. Howard Bleichner, P.S.S. (St. Mary's 1967) at the Sulpician retreat held last spring in San Antonio. On the same retreat, the Sulpician Province invited him to celebrate the Eucharist and preach a homily on his fifty-fifth anniversary of priesthood. The texts of the

Dr. John Macias has two works being published. An entry on Aquinas and beauty is coming out in *Vocabulário Teológico de Tomás de Aquino* (*Theological Vocabulary of Thomas Aquinas*). He also has an essay to be published as part of a collection of essays taken from a MacIntyre conference in the summer of 2021. The title of that essay is "Natural Law, the

Common Good, and Economics: A Difficulty for Thomists." He attended the American Catholic Philosophical Association conference in New Orleans in November 2022. He presented a paper entitled "The Practical Foundations of Natural Law," which will be published in Proceedings of the American Catholic Philosophical Association. Dr. Macias also presented a paper at the American Maritain Association conference in Dallas April 27–29.



In January 2023, **Dr. Bill Scalia** was invited to serve on the Presentations Committee for the Ralph Waldo Emerson Society. In May, he attended the annual American Literature Association conference in Boston, where he delivered his paper "Emerson, Motion Pictures, and the Poetry of Things."



Dr. Paul Seaton has accepted an offer from Sacred Heart Seminary and School of Theology in Wisconsin to help with coordinating their P-T program with the new Discipleship Stage of the PPF, 6th edition. Other activities included: his annotated anthology of Pierre Manent's writings on the religion of Humanity; *The Religion of Humanity*:

The Illusion of Our Times (St. Augustine Press), appeared; a review essay on Adrian Vermeuele's Common Good Constitutionalism ("Classical Historicism!") was included in "the best of 2022" list at Law & Liberty; an essay, "Benedict XVI and the Drama of European Culture," was published January 5 at Law & Liberty. Dr. Seaton remotely led a class on Benedict XVI on secular culture for the University of St. Thomas in Houston. He also wrote a review of a book on Alisdair MacIntyre that appeared on April 18 at the website "Law and Liberty."



Ms. Leelamma Sebastian attended a "Program of Parish Formation" workshop at St. Mary's Seminary in Cleveland, Ohio November 3–5. She also attended the "National Association of Lay Ministers' Task Force" meeting during the week of February 13. On April 21, she gave a presentation on "Pastoral Formation at St. Mary's" to the National Association of Lay

Ministers' (NALM) Task Force. On May 8 she attended the Catholic Association of Theological Field Educators (CATFE) conference.



Fr. Innocent Smith, O.P. has completed an article on liturgy in Thomas Aquinas that will be published soon in a Portuguese language encyclopedia, published by Edições Paulinas, titled Vocabulário Teológico de Tomás de Aquino (Theological Vocabulary of Thomas Aquinas). On Friday, October 21 Fr. Smith gave a talk titled "Arise, Let Us Be On Our Way: The

Eucharist and Evangelization" for the Thomistic Institute in New York City. On Friday, November 11, he gave a presentation on liturgical manuscripts at Dartmouth College. Between December 1 and 3, while attending the Academy of Homiletics in Louisville, Kentucky, he gave a presentation in the History of Preaching Seminar titled "Donatism and St. Augustine's Theology of Preaching." From January 2–5, 2023 he attended the North American Academy of Liturgy in Toronto and presented a paper on "Bible Missals and the Franciscan Liturgy" in the Issues in Medieval Liturgy Seminar. He led an intellectual retreat for college students sponsored by the Thomistic Institute in Washington, DC on January 13-15, titled "The Mystery of the Liturgy." Fr. Smith gave the invited keynote presentation for Ritual Life in the Medieval Dominican Order at the Pontifical Institute of Mediaeval Studies, University of Toronto, Canada, held March 6-7. His lecture was entitled "A Tale of Two Missals: The Missale Conventuale and Missale Minorum Altarium in Post-Humbert Dominican Manuscript Missals." He was invited to serve as an external reviewer for final semester projects for Dr. Audrey Seah's sacramental theology class at Loyola University Maryland that took place on Tuesday, April 25. After two years of admirable service to St. Mary's as an Assistant Professor and Director of Homelitics, Fr. Innocent's Dominican Province called him back to work at their school, the Dominican House of Studies, in Washington, DC, where he will be appointed an Assistant Professor of Systematic Theology.



Dr. James M. Starke presented on "Liturgy as Mystery" at the North American Academy of Liturgy's annual meeting, which was held January 2–4, 2023 in Toronto, Canada. He serves as a member of the Board of Directors of the Federation of Diocesan Liturgical Commissions and will attend the first of the Board's biannual meetings for 2023 in

Houston, TX on January 24–27. On April 30 Dr. Starke gave a talk at Saint Pius X Catholic Church in Norfolk, Virginia entitled "Liturgical Spirituality: Living the Liturgy." Dr. James Starke completed his STL in Systematic Theology in the Spring 2023 semester with a thesis on teaching liturgy in a Catholic seminary.

Stevens' appointment to that office, which includes sitting on the Rector's Formation Council, the Administrative Team, the Seminary Administrators' Team, the Deans' Council, and the Pastoral Leadership Institute Team. Fr.

Maillet will relinquish the position of Director of Spiritual Life Programs.



Fr. (Msgr.) Fredrik Hansen, P.S.S. has been appointed to the following administrative roles:

Dr. Barnabas Aspray's first degree is in Computer Science, and for a while he worked as a software engineer for the BBC website before changing career. He completed a theology PhD at Cambridge, and has spent the last four years teaching and researching for the Theology Faculty at Oxford ("the other place"

as Cambridge calls it). Dr. Aspray is a regular contributor to "Seen and Unseen", an online magazine aimed at explaining Christianity to a non-Christian audience. He is founder and host of "Faith at the Frontiers", a podcast which confronts challenges to the Christian faith with hope. Dr. Aspray grew up mostly in Britain and partly in Ecuador. As an adult he has lived in France, Canada, and the UK, and he looks forward to making America his new home. He will be Assistant Professor of Systematic Theology at St. Mary's.



Fr. Maximilian Maria Jaskowak, O.P. is a Dominican friar of the Province of St. Joseph (Eastern Province, USA). He entered the Order of Friars Preachers in 2016 and was ordained a priest in 2022. Earlier this year, he earned his licentiate in sacred theology (S.T.L.) from the Pontifical Faculty of the

Immaculate Conception in Washington, D.C. His areas of research include the theology of St. Thomas Aquinas, the Thomist Commentatorial Tradition, Sanjuanist and Teresian Theology, and Josephology. He is currently assigned to the Dominican convent of SS. Philip & James in Baltimore. He will be Instructor in Moral Theology.



Fr. Dominic Ciriaco, P.S.S., Rector of Theological College (2020-2023) is a New Jersey native. He attended Caldwell University, received a Master's of Divinity and a Master's in Systematic Theology from Immaculate Conception Seminary at Seton Hall University in South Orange, N.I., and

was ordained for the Archdiocese of Newark in 1999. He became a permanent member of the Society of St. Sulpice in 2020 and received his D. Min. degree in preaching from the Aquinas Institute of Theology in 2023. He has authored two books: Witnesses to the Gospel: Reflections on Saints and Others Who Inspire (Authorhouse Publications, 2007) and A Woman for All Seasons: Margaret Anna Cusack "The Nun of Kenmare": Reflections on Her Life and Liturgical Thought (Leonine Publications, 2015). Fr. Dominic Ciriaco will serve as the Director of the Homiletics Program and Director of Spiritual Life Programs.



Fr. Hy Nguyen, P.S.S., was ordained for the Diocese of Oakland, California, in 1997. He obtained an M. Div. and MA degree in theology from St. Patrick's Seminary in San Francisco, and his doctorate in dogmatic theology from the Pontifical Gregorian University in Rome. He has taught at St.

Mary's Seminary and University in Baltimore, and served as Vice-Rector and Director of Extern Spiritual Directors at Theological College at The Catholic University of America in Washington, D.C. He has also taught at the Oblate School of Theology in San Antonio and served as the Rector of Assumption Seminary in San Antonio, Texas. As a native of Vietnam, Father Hy has made significant contributions to the faith formation and growth of the Vietnamese community in the United States and Vietnam. Fr. Hy will be Associate Professor of Systematic Theology at St. Mary's.







IN MEMORIAM

- Msgr. Arthur J. Kaschenbach, SCC'45 and SMS'51, (Scranton), died on January 3, 2023, at the age of 96. He was ordained to the priesthood on May 19, 1951, by Bishop William Joseph Hafey, late Bishop of Scranton. Msgr. Kaschenbach served as Assistant Pastor at St. Peter's Cathedral, Scranton, from 1951 to 1968 when he was appointed Administrator of St. Patrick, White Haven. In 1973, he was assigned his second pastorate at St. Mary of the Mount, Mount Pocono, in 1977 where he remained until his retirement and appointment as Pastor Emeritus in 2006. Msgr. Kaschenbach was named a Prelate of Honor by Pope John Paul II on November 2, 1978 and given the title Monsignor. In addition to his parochial duties, Msgr. Kaschenbach also served as director of the League of the Sacred Heart from 1955 - 1991; Region V Chairman: "Follow Christ"; Office of Religious Education Regional Director; and Dean of Monroe County. A Pontifical Mass of Christian Burial was celebrated by Bishop Joseph C. Bambera, Bishop of Scranton, at Most Holy Trinity Parish in Cresco, PA.
- ₱ Francis J. Galloway, SCC'46, PS'48, and SMS'52, died on April 14, 2022, at the age of 94. Frank had a long career with the Federal Bureau of Investigation from 1950-1980. He also served in the U.S. Army in Japan during the Korean War. He was married to his wife, Patricia, for 47 years, until her death in 2008. He is survived by many nieces and nephews.

A Mass of Christian Burial was celebrated at Holy Family Catholic Church in Jacksonville.
- ♣ Fr. Paul L. Gregoire, SMS'55, (Manchester), died on December 29, 2022, at the age of 93. He was ordained to the priesthood on June 4, 1955, at St. Joseph Cathedral in Manchester. He became a member of the Society of St. Sulpice and taught at seminaries in Baltimore, California, and Seattle. A funeral Mass was celebrated at Our Lady of the Fields in Millersville.
- Fr. Robert G. Park, PS'53 and SMS'57, (Wheeling-Charleston), died on May 3, 2023, at the age of 93. He was ordained to the priesthood on June 1, 1957, at St. Francis Xavier Church in Parkersburg by Bishop Thomas J. McDonnell. During his nearly 66 years in the Diocese of Wheeling-Charleston, Fr. - Fr. K. Michael "Mick" Lambeth, SMS'93, (Trenton), died on May 29, 2022, at the age of 74. He was ordained to the priesthood on May 21, 1994, by Bishop John C. Reiss. During his 28 years as a priest in the Diocese of Trenton, Fr. Lambeth served in several parish roles, including Pastor of three parishes and as Diocesan Director of Vocations and the Sacred Heart House of Priestly Formation in Trenton. Before becoming a priest, he served in the U.S. Navy, making four tours of duty in the Vietnam War on the Naval Destroyer Ozbourn DD-846, and later worked for two retail chains. Fr. Lambeth was the retired pastor of St. Theresa Church, where he served from 2008-2019. A funeral Mass was celebrated at St. Thresa Church in Little Egg Harbor, with Bishop David M. O'Connell, C.M. presiding, and Fr. Joe Noche (SMS'07) as homilist.
- Fr. Jonathan A. Woodhall, Ph.D., SMS'99, (Raleigh), died on December 20, 2022, at the age of 82. He married Sally Campbell Woodhall in 1968, and went on to teach Latin and Religion at Convent of the Sacred Heart in Noroton Heights, CT, and then served as Dean of Studies at Villa Duchesne in St. Louis, MO. In 1974, he and his family returned to Connecticut, where he became Assistant Headmaster, then later Headmaster, at The Oxford Academy in Westbrook, CT. He was ordained a Deacon in the Diocese of Norwich, CT. In 1983, he and his wife established the Woodhall School in Bethelem, CT. He served as the first President of the Board of Directors of The Woodhall School, then Co-Head of School, and finally, Director Development. After his time at Woodhall, he was ordained to the priesthood for the Diocese of Raleigh in 1999. He served as Parochial Vicar at Sacred Heart Cathedral in Raleigh from 1999-2006. After his retirement, he stayed active in ministry and pastoral outreach. A funeral Mass was celebrated at Holy Name of Jesus Cathedral in Raleigh.

♣ Msgr. Raymond A. Barton, I.C.E., (Richmond), died on September 17, 2022, at the age of 82. He was ordained to the priesthood for the Diocese of Richmond on May 14, 1966. He served in at least six parishes during his 56 years in the Diocese of Richmond. In 1977, Msgr. Barton, along with Episcopalian priest, The Rev. Donald A. Gross, became the first co-pastors of the Church of the Holy Apostles in Virginia Beach. Holy Apostles combines the liturgies of the Catholic Mass and Episcopalian Holy Eucharist into one serv-

ice for inter-faith and single faith families. Holy Apostles is a symbol of ecumenism, a concept to which Msgr. Barton remained committed throughout his life. On January 26, 1997, Father Barton was honored with the title "Monsignor" due to his years of dedicated service and many contributions to the Church. In 2006, he was appointed President of the Virginia Council of Churches, and that same year he received the Faith in Action Award from the Council. He retired from active ministry in 2011. A Mass of the Resurrection was celebrated at St. Nicholas Catholic Church in Virginia Beach.

- Former Board Consultant, Mr. William Baird, Jr., died in August 2022. Mr. Baird, a life-long Baltimorean and devout Catholic was an active volunteer throughout the Archdiocese of Baltimore and a longtime member of the Seminary's Advancement Committee. Mr. Baird and his wife, Joanna, had eight children, 19 grand-children and one great-grandson. His son, William Baird III served as a trustee on the St. Mary's Seminary Board for over a decade.
- ♣ Mary C. Mangione, long-time benefactor of St. Mary's, died in March 2023. Mary and her husband Nick (who preceded her in death) were married over 50 years and established many businesses including Turf Valley Hotel/Golf Course Resort and residential community. Mr. and Mrs. Mangione were extraordinarily generous to St. Mary's over many years and were leadership donors to the Pope John Paul II Reading Room established in 2007. Fr. Leavitt, former President Rector, celebrated the Mass of Christian Burial for Mary on March 18, 2023.
- Former faculty member, Fr. Dominic Maruca, S.J., died in August 2022. For many years Fr. Maruca's pastoral ministry focused on priestly and spiritual formation. In 1979, he was assigned to Rome, where he taught at the Pontifical Gregorian University Institute of

- Spirituality (1979-1997). In 1997, he returned to Baltimore where he served as the Spiritual Director of the Center for Continuing Formation until 2001.
- # Mr. Joe Molyneaux, long-time board member of both St. Mary's Seminary and St. Mary's Ecumenical Institute, died on August 31, 2022. At the time of his death, Mr. Molyneaux was still actively serving on both boards. He joined the seminary board in 2003 at the invitation of Fr. Leavitt, and the Ecumenical Institute board a few years later. Joe was tireless in his work to support the entire institution and was personally responsible for the initiative that brought the former Archbishop of Canterbury, Rt. Rev. Rowan Williams, to St. Mary's for a standing room only lecture in 2014. In addition to St. Mary's, Joe served on the boards of Mother Seton Academy and Boys Hope Girls Hope of Baltimore. Joe is survived by his five children and his widow Terri Huidobro. It would not be possible to overstate Joe's dedication and devotion to St. Mary's Seminary and the Ecumenical Institute. At the October 2022 Board Meeting, Fr. Moore announced that the Sulpician Provincial Council was honoring Joe Molyneux's legacy with a leadership gift in his name to the Bishop Doll Scholarship supporting the DMin. program of St. Mary's Ecumenical Institute.

Fr. Howard P. Bleichner, P.S.S. Jan. 11, 1934 – Dec. 14, 2022

♣ Fr. Howard P. Bleichner, P.S.S., passed away while under a physician's care in the early evening of Wednesday, December 14, 2022, in Pittsburgh, PA. For a decade after leaving teaching and a retirement in California, he had been living in Pittsburgh near his family at Brookdale Senior Living following his

diagnosis with Parkinson's Disease. A Mass of Christian Burial was celebrated for the repose of his soul on December 20, 2022, at his home parish, St. Basil's Church, with Bishop David Zubik (SMSU, Pittsburgh, Class of 1975) presiding and with his classmate, Rev. Clem Gardiner, (SMSU, Altoona-Johnstown, 1967) preaching. Pittsburgh priests and St. Mary's alumni concelebrated his funeral Mass.

After earning a B.A. in history from Dartmouth College in New Hampshire, Howard Bleichner began his philosophical studies for priesthood at St. Vincent Seminary, Latrobe, PA. He entered St. Mary's Seminary

at Roland Park in 1963 sponsored by the Diocese of Pittsburgh. Rev. David Fulton (SMSU Metuchen, 1967) and former faculty member and administrator at St. Mary's, remembers his seminary classmate, Howard Bleichner, as very mature, concerned in conversation and class more with the mysteries of the faith than with the abstractions intended to capture them, and at times disarmingly clever with words. Following ordination in 1967, out of a respect and admiration for those Sulpicians who taught him at Roland Park, Father Bleichner became a member of the Society of St. Sulpice. To prepare himself for his future ministry and for his fluency in German, he undertook doctoral studies in systematic theology at the University of Tubingen (Germany) which awarded him Dr. Theol. in 1973 for a thesis on the Harvard philosopher William James.

From the beginning of his national career in three Sulpician theologates until the end of his life, part of Father Bleichner's reputation rested in the rare ability he possessed for explaining and creatively interpreting the faith for seminarians. He demonstrated the gift first in the 1970s at St. Mary's Seminary, his alma mater. He brought the same academic and spiritual talents with him to St. Patrick's Seminary (Menlo Park) in the Archdiocese of San Francisco where he was a faculty member and then rector (1978-1988). Finally, as rector of Theological College at The Catholic University, in Washington, D.C. (1992-2002), his conferences were his hallmark. Seminarians in those institutions remember the way he illuminated abstract ideas by covering them with unusually apt images and metaphors drawn from ordinary life. The delivery was never showy on his part -- the presentation in fact was understated -- yet the mastery of Catholic history, spirituality, and theology he displayed were, on occasion, stunning. For his broad seminary experience and excellent judgement in priestly formation, the Bishops Committee on Priestly Formation appointed Father Bleichner to prepare and edit the 4th edition of the USCCB Program of Priestly Formation. He later authored two books which captured his own

distinctive approach to priestly formation for Crossroad Publishing Company, A View From the Altar: Reflections on the Rapidly Changing Catholic Priesthood and In the Circle of the Mysteries: The Coherence of Catholic Belief.

Another St. Mary's classmate, Rev. Raymond Kemp (SMSU Washington, D.C., 1967), especially recalls the calm demeanor and sure sense of competency he already possessed as a seminarian and throughout his life. There were no wasted motions, no beating around the bush. From their time as seminarians together through the years of priesthood, it was the innate confidence of an acute reader of the signs of the times in

Father Bleichner that stood out. Besides a formidable native intelligence and a witty sense of humor, there was also a deep humanity in him. Living at Santa Cruz at the end of his teaching career, Father Bleichner would regularly take dinner to a neighbor, an elderly lady, to chat before joining a savvy crowd of Holy Names Sisters at Villa Maria del Mar Retreat House to share their table and stimulating conversation. The frank and honest way he saw things went together with the careful listener in him and confidante to leaders that he could be.

A wisdom-figure in the best sense of the word, telling it like it is, decisive when the situation called for it, a servant-leader to seminarians, priests, and bishops is what he was. In the best sense of the word, Father Howard Bleichner was a model of what Vatican II taught about the priesthood – a man dedicated to the Word of God in Sacred Scripture and Tradition, a compelling teacher of the faith and preacher, a prayerful celebrant of the Mass and the other sacraments, a smart and practical shepherd for those he was called to serve and a competent leader of seminary institutions on the national scene. Mature in his own spirituality and virtuous in life, he was an example of what the Sulpicians cultivated in him during the four years he spent at Roland Park during Vatican II. During the Pontificate of John Paul II, Father Bleichner was highly regarded by bishops and priests around the country who sought his expertise and inspiration as one of the most admired members of the Society of St. Sulpice in the United States.

May he now rest in peace.
